

## WEBSITE PRIVACY POLICY

La Jolla Pharmaceutical Company (“La Jolla”, “Company”, “we” or “us”) respects the privacy of visitors to its website and is committed to the protection of your personal information. We have developed this Privacy Policy to summarize how we collect, maintain and use personally identifiable information through this website.

Please note that this Privacy Policy applies only to information collected from you by the Company via the website (including information sent to email addresses provided on the website) and does not apply to information obtained or disclosed through offline correspondence or personal contacts with the Company’s representatives.

By using the website, you agree to this Privacy Policy. The Company reserves the right, in its discretion, to change, modify, add or remove portions of this Privacy Policy at any time without prior notice to you. All revisions will be posted to the website. We urge you to review this Privacy Policy frequently for changes. Your continued use of the website means that you accept those changes.

## PERSONAL INFORMATION

La Jolla may collect and process the following kinds of information:

- Personally identifiable information (e.g., information from which you can be identified, such as your name, address, telephone number, email address, date of birth or other similar information), demographic, or other health information (collectively, “Personal Information”) when you voluntarily provide this information to us or when you give permission to others (such as your healthcare provider) to share such Personal Information with us. Healthcare providers may choose to provide information such as specialty or professional affiliations.
- Non-personally identifiable information relating to such things as the total number of visits to our website, the number of visitors to each page of our website, the Internet Protocol (IP) addresses of our visitors and the browser version you are using, the date and time of access, the time spent on our website and the domain names of our visitors’ internet service providers.
- Additionally, we may compile or use your Personal Information with information obtained from third parties, for example to confirm contact or financial information or current licensure status, or to better understand your interests.

## HOW WE USE PERSONAL INFORMATION

La Jolla may use Personal Information in a variety of ways. Your Personal Information may be used to:

- Respond to comments or requests for information;
- Provide any requested information, products or services;
- To consider your application for employment;
- Troubleshoot problems with the website, or any services, as requested;
- Customize and/or improve your experience with the website or the content of the website;

- To better understand how our products and services impact you, to track and respond to safety concerns and to further develop and improve our products and services;
- To identify those who benefit from or recommend our products and services;
- Enforce our Terms of Use and/or this Privacy Policy; or
- Provide you with information about La Jolla and its products or services that we believe you will find most relevant;
- Serve third parties you ask us to serve, for example third party sharing functionality such as social media tools. As with all third party links, we encourage you to review the privacy policies and terms associated with these third party properties.

If you do provide Personal Information to us, you agree that we may contact you through a variety of methods including e-mail, postal mail and telephone. In addition to the above, La Jolla may use both Personal Information and non-personally identifiable information to improve the content of our website, to customize our website to your preferences, to understand how our visitors use our website so that we can improve the website and the customer experience, and for internal research purposes. We may also use your IP address to help diagnose problems with our servers and for the purpose of system administration. We may also aggregate your Personal Information with other data and use such aggregated data to help us improve our products and services.

If you contact us to report on your experience with the use of our products or services, we may contact you for follow up information.

#### CONSENT TO PROCESSING IN THE UNITED STATES AND ELSEWHERE

Any information you provide to La Jolla through use of the Site may be stored and processed, transferred between and accessed from the United States and other countries which may not require the same level of protection of personal information as the country in which you reside. This site is owned and operated by La Jolla in the United States, but the Personal Information you provide may be accessible to our affiliates, vendors and suppliers in other countries. If you are visiting this site from a country other than the United States, your Personal Information collected on this site will be transferred outside of your country. By using this site, you consent to the collection, storage, and processing of your Personal Information in the United States and in any country to which we may transfer your information in the course of our business operations. However, La Jolla will handle your personal information in accordance with this Privacy Policy regardless of where your personal information is stored/accessed.

#### DISCLOSURE OF PERSONAL INFORMATION

We reserve the right to disclose your Personal Information to third parties based on the good faith belief that such action is necessary or appropriate to: (a) protect and defend the rights or property of La Jolla or (b) act in urgent circumstances to protect the safety or security of the public or of users of La Jolla's products, services and/or the website, or (c) to comply with applicable law. We may use third parties to provide services and information and we may provide some co-branded services in partnership with others. We also may use third parties to analyze data collected in the course of our normal business operations, including on this website. We will not disclose your personally identifying information to

anyone other than our employees and those third parties with whom we have a business relationship. We may share aggregate non-identifiable information with third parties for research purposes and to analyze and report market trends.

In the event that La Jolla is involved in a corporate transaction such as a reorganization, joint venture, assignment, merger, stock purchase or sale, sale of substantially all of La Jolla's assets or similar transaction (including in connection with a bankruptcy or similar proceedings), your Personal Information may be shared with and transferred to the other party in connection with such transaction. Other than as provided in this Privacy Policy, or as required by law, La Jolla will not trade, sell or share your Personal Information for use by any third party without your consent.

#### HOW WE PROTECT PERSONAL INFORMATION

La Jolla is committed to protecting the security of your Personal Information. La Jolla takes reasonable steps to protect your Personal Information as you transmit it to our website and to protect your Personal Information from loss, misuse, unauthorized access, disclosure, alteration or destruction. The data you provide us will be held on a secured web server operated by La Jolla or an agent performing services on our behalf. Unfortunately, the confidentiality of any Personal Information or the transmission of information via the Internet or email is not completely secure or error-free, and La Jolla cannot guarantee the security of any data transmitted to us. You should also recognize that your use of the Internet and our website is solely at your own risk.

#### COOKIES

When you visit our website we may obtain information about your Internet usage by using a cookie file, which is a text file stored on the hard drive of your computer. We do not collect Personal Information with our cookies but we use them to improve our website, gather aggregate usage metrics and deliver a more personalized service, including enabling us to track the interests of our users, to estimate our audience size and usage patterns, to recognize our users when they revisit our website, to store information about your preferences and allow us to customize our website in accordance with your interests, and to speed up your searches. Web browsers typically accept cookies by default but you may change the settings of your browser to stop accepting cookies or to prompt you before accepting cookies from websites. However, if you configure your browser to stop accepting cookies, you may be unable to properly use certain parts of our website.

#### EMAIL

You may receive emails from La Jolla. You can unsubscribe by clicking on the links available in our emails. On our website, you can choose to use a "Share" service to send content from the website to someone else. In such case we may ask you for information such as their email address as well as your name and email address. The information you provide will be used to send a single message by us on your behalf. This information will not be collected or stored for any additional purpose.

#### STORAGE OF PERSONAL INFORMATION

Personal Information collected on our website may be stored and processed in your country of residence or any other country in which La Jolla or its affiliates, subcontractors or agents maintain facilities, and by using this website, you consent to any transfer, storage or processing of data outside of

your country of residence. La Jolla will ensure that if data is transferred outside of your country of residence, it will still be treated in accordance with this Privacy Policy.

#### LINKS TO OTHER WEBSITES

Our website may contain links to and from websites maintained by third parties that may provide useful information to you. If you follow a link to any of these websites, please note that these websites may have their own privacy policies. La Jolla is not responsible for the privacy practices or the content of such other sites. We encourage you to check these policies before you submit any personal data to these websites.

#### CHILDREN UNDER 18

The website content and services are intended for users over the age of 18. The website is not designed to attract child users, and we do not knowingly collect Personal Information from any person under the age of 18.

#### YOUR PRIVACY CHOICES
